GROUP POLICY AMENDMENT NO. 10

Attached to and made a part of Group Policy 753380-A issued to Washington Council of Police and Sheriffs as Policyholder.

Effective April 1, 2019, and subject to the **Active Work Provisions**, the Group Policy is amended as follows:

- 1. Item 2.b. of part E. When Life Insurance Becomes Effective of the **Life Insurance** section is amended to read as follows:
 - b. Contributory Life Insurance

You must apply in writing for Contributory Life Insurance and agree to pay premiums. Contributory Life Insurance not subject to Evidence Of Insurability becomes effective on:

- (i) The date you become eligible, if you apply on or before that date.
- (ii) The date you apply, if you apply within 60 days after you become eligible.

Late application: Evidence Of Insurability is required if you apply more than 60 days after you become eligible.

<u>Note</u>: For Employers requiring 100% Member participation, Contributory Life Insurance becomes effective on the date you become eligible. You are not required to apply in writing.

- 2. Item 2.b.2. of part E. Becoming Insured for Dependents Life Insurance of the **Dependents Life Insurance** section is amended to read as follows:
 - 2. Contributory Dependents Life Insurance

You must apply in writing for Contributory Dependents Life Insurance and agree to pay premiums. Contributory Dependents Life Insurance not subject to Evidence Of Insurability becomes effective on the latest of:

- i. The date your Life Insurance becomes effective, if you apply on or before that date;
- ii. The date you become eligible to insure your Dependents, if you apply on or before that date; and
- iii. The date you apply, if you apply within 60 days after you become eligible.

Late Application: Evidence Of Insurability is required for each Dependent if you apply more than 60 days after you become eligible.

<u>Note</u>: For Employers requiring 100% Member participation, Contributory Dependents Life Insurance becomes effective on the date you become eligible. You are not required to apply in writing.

- 3. Item 2.b. of part G. Becoming Insured for AD&D Insurance of the **Accidental Death And Dismemberment Insurance** section is amended to read as follows:
 - b. Contributory AD&D Insurance

You must apply in writing for Contributory AD&D Insurance and agree to pay premiums. Contributory AD&D Insurance becomes effective on the later of:

(i) The date you become eligible, if you apply on or before that date.

(ii) The first day of the calendar month coinciding with or next following the date you apply, if you apply after you become eligible.

Note: For Employers requiring 100% Member participation, Contributory AD&D Insurance becomes effective on the date you become eligible. You are not required to apply in writing.
